## Directions for Use

- Half fill sprayer tank with water.
- Calculate the required amount in ratio to spray volume being used.
- Shake container thoroughly. Add the required amount through top filter of sprayer.
- Wash through filter with water. Add remainder of water required and agitate for 3 minutes.
